

2017 Havoline ACC Sweepstakes
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Sweepstakes Description. The 2017 Havoline ACC Sweepstakes (“Sweepstakes”) is offered and sponsored by Chevron Products Company, a division of Chevron U.S.A. Inc., 6001 Bollinger Canyon Road, San Ramon, CA 94583 (the “Sponsor”) and Raycom Sports Network, LLC, 1900 West Morehead Street, Charlotte, NC 28208 (the “Administrator”). Sweepstakes entry period begins on January 15, 2017 and ends at midnight Eastern time on February 19, 2017 (the “Entry Period”). On February 22, 2017 a random drawing will be held from all entries received during the Entry Period, and one (1) prize will be awarded in accordance with these Official Rules. To be eligible for this Prize, entries must be received during the Entry Period. This Sweepstakes is void where prohibited and subject to all local, state, and federal laws and regulations. By entering this Sweepstakes, you agree to be bound by these Official Rules and all decisions of the Sponsor and Administrator.

2. Eligibility. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A purchase will not increase your chance of winning. Open to legal residents of the 48 continental United States and the District of Columbia. Entrants must be 21 years of age or older at time of entry. Void where taxed, restricted, or prohibited by law. None of the following are eligible to participate in the Sweepstakes or win a prize: current or former employees of Sponsor, Administrator, The ACC or any of their subsidiaries, affiliates, parent companies, agents, successors, assignees, advertising, promotion or any other agencies or entities involved with this Sweepstakes (collectively the “Sweepstakes Entities”) and members of the families, (biological, step or in-law) including parent, grandparent, child, sibling or spouse of any of the foregoing (regardless of where they live) or households of any of the above, whether related or not. By entering, you agree that the Sponsor, Administrator and Sweepstakes Entities are not responsible for any disciplinary action, suspension, probation, or any other punishment taken by your university or sports association for any conduct or behavior related to this Sweepstakes.

3. How to Enter. All those who wish to enter and are eligible can do so at any time during the Entry Period via <http://ACCSweeps.HavolinePromotions.com> (the “Page”). Once on the Page, the Entrant must provide all the required information requested on the Official Entry Form (the “Entry”), including complete name (first and last, no initials), valid email address, mailing address and phone number.

To enter by mail, mail in your valid email address, complete name (first and last, no initials) to: Raycom Sports – Havoline Sweepstakes, 1900 W. Morehead Street, Charlotte, NC 28208. All mail-in entries must be received by February 19, 2017. The Sponsor and

Administrator are not responsible for mail-in entries that are lost, stolen, not received, destroyed, damaged, misdirected, illegible, incomplete, fraudulent, late, or postage due, all of which will be disqualified.

Each eligible person that enters the Sweepstakes shall be referred to hereinafter as "Entrant." Limit 1 entry per person for the duration of the Sweepstakes regardless of the method of entry.

To be considered eligible for the Prize, completed Entries (whether electronic or by mail) must be received by midnight Eastern time on February 19, 2017. Entries will not be acknowledged or returned. By entering this promotion, entrant agrees that the Sponsor and/or Administrator of this promotion may provide entrant with promotional materials and may release entrant's personally identifiable registration information to other sponsors for that purpose. Entries generated by automated means are void.

For online entries, the authorized account holder of the e-mail address submitted at time of entry will be considered the entrant. An "authorized account holder" shall mean the natural person assigned to such e-mail account by the Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with such e-mail account. A potential winner may be requested to provide proof that he or she is the authorized account holder of the e-mail address associated with a winning entry.

4. Selection of Winner. On Wednesday, February 22, 2017 at or about 10:00 a.m. Eastern time, one (1) potential prize winner will be selected at random from the qualified Entries using an independent auto-generated selection process to determine the potential Prize winners for the Sweepstakes (the "Winner").

A potential Winner must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements, including but not limited to those set forth in Section 7 below.

5. Prize. There will be no more than one (1) prize **awarded on February 22, 2017** (the "Prize"). Entries must be received during the Entry Period to be eligible for this Prize. This Prize will consist of round trip coach airfare for two (2) from any airport in the lower 48 states to a New York, NY area airport (ARV: \$1,300), one (1) double-occupancy room for up to five (5) nights, March 7 - 11, 2017 at a hotel to be later named by the Administrator, in its sole discretion (ARV: \$1,600), two (2) tickets to up to fourteen games of the 2017 New York Life ACC Basketball Tournament at the Barclays Center (ARV: \$894), two (2) tickets to

the 2017 ACC Men's Legends event (ARV: \$120), PLUS an additional \$500. The number of hotel nights and the number of games attended as part of the Prize will be based on when the confirmed winner fulfills all requirements set forth in these Official Rules and arrives in New York, NY. (EX: If Winner's travel schedule is such that they arrive in New York, NY on Wednesday, March 8, Winner will not receive tickets to the Tuesday, March 7th games.) No more than One (1) prize advertised herein will be awarded. All travel plans, including but not limited to airline carrier, travel routes, hotel accommodations, class of travel, and dates and times of travel, will be in Administrator's discretion. If Winner chooses to travel or attend the Basketball Tournament alone, no additional compensation will be awarded.

All other expenses not specifically mentioned herein are solely the responsibility of the Winner. Estimated total retail value of the Prize package is \$4,414.00. If the Prize is refused or the Winner selected is not eligible, it will be forfeited and may be awarded to an alternate potential winner from all qualified eligible Entries received. No more than one (1) Prize advertised herein will be awarded. The Prize is not transferable to cash or another person.

The Administrator and/or Sponsor reserve the right to substitute the Prize or any portion thereof for a prize of at least equal value in the event of unavailability, Act of God or for any reason whatsoever. The Sponsor, Administrator and Sweepstakes Entities are not responsible if the Prize is lost, stolen or mutilated and the Prize will not be replaced. The value of the Prize may be taxable as income; Winner is responsible for any applicable taxes. All taxes, fees, duties and surcharges on the Prize and/or the redemption thereof are the sole responsibility of the Winner. Winner and guest agree to indemnify and hold harmless the Sponsor and Administrator and their employees and agents from and against any liability for such taxes.

6. Odds of Winning. Odds of winning depend upon the number of Entries.

7. Prize Redemption. A selected Entrant will be notified by e-mail via the e-mail address provided in their Entry. The e-mail will be deemed to have been received after 24 hours from the time of sending. The selected Entrant will then have 48 hours to respond by following the instructions provided in the e-mail. Within the initial e-mail, the selected Entrant will be provided with the Sponsor's declaration and release form, confirming compliance with the Official Rules and releasing the Sponsor, Administrator and their affiliates, and respective advertising and promotional agencies from all liability as well as W-9 and other applicable tax forms ("Sweepstakes Forms"). The Sweepstakes Forms must be completed and returned to the Sponsor within two (2) business days of it having been sent. A potential Winner is not an official and confirmed Winner until he/she has completed, signed and returned all required Sweepstakes Forms. If the selected Entrant cannot be contacted, fails to complete, sign and return the Sweepstakes Forms within the time frames stated in this paragraph he or she will be disqualified and an alternate Entrant may, at the sole discretion of the Sponsor and Administrator, be selected in his or her place from among all remaining Entries generated during the contest Period. The Sweepstakes

Entities are not responsible for late, lost, stolen, delayed, illegible, incomplete, destroyed, misdirected or unsuccessful Sweepstakes Forms or efforts to notify selected Entrant. The Prize (and any components thereof) must be accepted as awarded in the name of the Winner and may not be transferred or assigned prior to pick-up, or exchanged and has no cash surrender value in whole or in part.

Winner will be solely responsible for any and all local, state and federal taxes, as well as license and registration fees, if any, transportation costs and other items of an incidental nature. Sponsor and Administrator will report any individual's winnings over \$600 (in case or fair market value of goods or services) in a one year period to the Internal Revenue Service. Winner will receive a Form 1099 from Sponsor(s). Winner must agree to provide required personal information to the Sponsor and Administrator in order to generate tax documents, if required.

8. Release. By participating, Entrants agree (a) they have complied and to be bound by these official rules; and (b) to release the Sweepstakes Entities and each of their respective officers, directors, employees and agents from any and all liability, loss or damage incurred with respect to their participation in this promotion and to the awarding, receipt, possession and use or misuse of a Prize; and (c) agree to use of his/her name, voice, likeness, biography, opinions, and city of residence for advertising, publicity and promotional purposes in any media worldwide without compensation (unless prohibited by law); and (d) Sponsor, Administrator, The ACC, and any other sponsor(s) of this promotion may provide Entrant with promotional materials and that the Sponsor and/or Administrator may release Entrant's personally identifiable registration information to the other sponsor(s) for that purpose. Entrant agrees that Sponsor, Administrator and the ACC are not responsible for the use of Entrant's personally identifiable information by the other sponsor(s). Taxes on the Prize, if any, are the sole responsibility of Winner. The Prize cannot be transferred, assigned or redeemed for cash or substituted except at Sponsor's sole discretion, or as provided herein. All federal, state and local laws and regulations apply.

9. Limitations of Liability. Each Entrant, as a condition of participating, releases and agrees to indemnify and hold harmless the Sponsor, Administrator and Sweepstakes Entities and all of their respective directors, officers, employees, representatives, agents, successors and assigns from any and all claims, demands, liability, judgments, fines, costs, or expenses (as well as reasonable attorney's fees), including but not limited to any and all claims of personal injury, loss or damage of any kind to person(s), including death, and property, invasion of privacy or transfer of personally identifiable information, merchantability or fitness of the Prize for any specific purpose, and/or breach of contract, arising in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of a Prize or participation in any Sweepstakes related activity or Prize-related travel, or participation in this Sweepstakes.

Neither Sponsor, Administrator, nor any participating promotion agencies or Prize providers are responsible for any incorrect or inaccurate information or for any faulty or failed electronic data transmissions, lost, late, damage, misdirected Entries, incomplete or

inaccurate capture of Entry information (regardless of cause). Sponsor and Administrator are not responsible for contacting any Entrant if that Entrant has changed contact information and failed to provide Sponsor and Administrator with the proper contact information when such information is required. If, for any reason, the Sweepstakes is not capable of running as planned for any reason which Sponsor and Administrator, in their sole opinion, deems could corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes and/or these Official Rules, in whole or in part, and if possible, to select the contestants from Entries received prior to the action taken or as otherwise may be deemed fair and appropriate by Sponsor and/or Administrator.

Sponsor and Administrator reserve the right at their sole discretion to disqualify any individual found to be tampering with the entry process or the operation of this Sweepstakes; or to be acting in any manner deemed by Sponsor and Administrator to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor and Administrator to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person or interfere in any manner with any aspect or portion of this Sweepstakes. Any use of robotic, automatic, macro, programmed, copied, or like entry methods, will void all such Entries by any methods, and will disqualify any Entrant using such methods. Additionally, Sponsor and Administrator reserve the right to prosecute any fraudulent activities to the full extent of the law.

These official rules are subject to modification by Sponsor and Administrator. In the event of a dispute, all decisions made by Sponsor and Administrator are final and binding.

IN NO EVENT WILL SPONSOR, ADMINISTRATOR AND ANY PARTICIPATING PROMOTIONAL COMPANIES OR PRIZE PROVIDERS, OR THEIR RESPECTIVE PARENTS, AFFILIATES, SUBSIDIARIES AND RELATED COMPANIES, THEIR ADVERTISING OR PROMOTION AGENCIES OR THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, REPRESENTATIVES, AGENTS, SUCCESSORS AND ASSIGNS BE LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES.

CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVE THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

10. Arbitration/Choice of Law. Except where prohibited, Entrants in this Sweepstakes agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes, or the Prize awarded, or the administration of the Sweepstakes or the determination of the Winner, shall be resolved individually, without resort to any form of class action, and exclusively by arbitration, to take place in the U.S.A. pursuant to the Rules of the American Arbitration Association, the effective, (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes but in no event attorneys' fees; and (3)

under no circumstance will an Entrant be permitted to obtain awards for and Entrants hereby waive all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. Except where prohibited, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Entrant(s), Administrator and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of North Carolina without regard to conflicts of law doctrine.
